

FKN ARMY COMPETITION RULES AND TERMS AND CONDITIONS

1. INTRODUCTION

These Competition Rules and Terms and Conditions govern all competitions organized by FKN Army NPC and are submitted in compliance with the requirements for the registration of a society.

2. KEY WORDS AND DEFINITIONS

The following words shall have the meaning given below.

"Accountant" the accountants, appointed to oversee and monitor the Competition by the FKN Army being Mani Financial Services;

"Announcement Date" the date the winner of the Prize will be announced being the date of the competition;

"Closing Date" means the **14th of December 2025, 00:00** being the last date to buy an entry ticket;

"Draw Date" **15th of December 2025, at Sunward Motors Silverton** being the date that the Eligible Tickets will be determined as per the Initial Draw;

"Initial Draw" means the lucky (randomized) draw from the list of Tickets to determine the three Competitors will be eligible to compete for the Prize during the Competition as further described below;

"Eligible Tickets"	the three Tickets chosen as per the Initial Draw, the holders whereof will be invited to compete in the Competition to win the Prize;
"FKN Army"	FKN Army (NPC) being a non-profit company with Registration Number 2022/301204/08, address at 26 Tungsten Street, Witbank, Mpumalanga, 1035 and the promotor of the Competition;
"Competition"	a Put Put Golf Competition to take place between the holders of the Eligible Tickets on the Competition Date;
"Competition Date"	competition will run from [5 October 2025] to [14 December 2025], unless otherwise specified. Late entries will not be accepted;
"Start Date"	the date whereupon the Competition was announced and Ticket sales open;
"Ticket"	an entry ticket for the Competition entitling the Ticket Holder thereof to participate in the Draw;
"Ticket Holder"	the holders of an entry Ticket;
"Rules"	these terms and conditions;
"the Competition"	the random draw to be held in accordance with the Rules in terms whereof a Ticket Holder will win the Prize;
"the Prize"	Prizes will be clearly stated in the competition announcement. Prizes are non-transferable and may not be exchanged for cash or other alternatives;
"the Winner"	the winner of the Live Draw and who will receive the Prize.

3. The Competition relates to the Prize as described in the competition announcement.
4. The Prize is supplied by Sunward Motors Silverton (Pty) Ltd.
5. The profits of the ticket sale, after deduction of amounts for expenses and prizes, shall be solely applied for recognised charitable purposes as per the FKN Army's non-profit purposes.
6. Competitors must make their own travel arrangements to attend to the Competition and at their own cost .
7. Requirements for participation in the Competition.
 - 7.1. Only holders of a valid Ticket shall be eligible for the Initial Draw;
 - 7.2. Ticket sales will end at the **Closing Date 14 December 2025**. Ticket sales will as such end at midnight the **14th of December 2025**.
 - 7.3. A person may buy multiple Tickets, the price of a ticket will remain the same no matter the number of Tickets bought;
 - 7.4. In order for a Ticket to be valid, the Ticket must be bought and paid up, by the Closing Date;
 - 7.5. Entry into the Competition shall be by means of Tickets registered and paid for by completing the required entry form on the FKN Army Website <https://www.fknarmy.com/> and by means of making payment of the required cost of the Ticket to the FKN Army.
 - 7.6. All holders of Tickets as at the Draw Date will qualify for the Initial Draw.
8. How Competition winner will be determined:

- 8.1. The Prize in the Competition will not be awarded to any person who is a director, member, partner, employee or agent of, or consultant to the FKN Army or any other person who directly or indirectly controls, or is controlled by, the FKN Army, or a supplier or sponsor of goods in connection with the Competition.
- 8.2. As at the Closing Date the Accountant will determine a list of all Ticket Holders and Tickets sold.
- 8.3. Each Ticket sold, as aforesaid, will be assigned a single unique, sequential number by the Accountant.
- 8.4. Three tickets will be drawn by hand within a fan operated glass cubicle, which will be broadcast live on Fkn Army's social media page. The final winning Ticket shall be determined as below.
- 8.5. The Initial Draw will take place on the **15 December 2025** at 14h00.
- 8.6. To determine the final winner out of the **three** randomly selected Tickets (herein the "Eligible Tickets") as per the Initial Draw the three Ticket Holders will be invited to take part in the Competition that will take place at **Sunward Motors Silverton**. The Competition will commence on 17 December 2025 at 11h00.
- 8.7. Rules of the Put Put Competition will be determined by the FKN Army
- 8.8. The Competition will be skill based, and contestants will be required to take part in the Put Put Competition.
- 8.9. The Competition will consist of **3** (rounds) of putting.
- 8.10. The Winner will be the Contestant who achieves the lowest score (lowest amount of puts) to put the ball in the hole. In the case of even scores the Contestants with matched lowest scores will put against each other in an elimination match to determine the Winner.

- 8.11. Putting order to be determined by coin toss.
- 8.12. If a Competitor is unable to attend to the live draw, they must notify the FKN Army and a new Competitor will be determined by random (RNG) draw from the pool of Ticket Holders.
- 8.13. The Ticket Holder who wins the Competition will win the Prize.
- 8.14. If it transpires that the winning Ticket Holder is disqualified from receiving the prize, the Second-Place holder in the Competition will be declared as Winner.
- 8.15. Should a Ticket Holder accept the prize, and it only become apparent afterwards that the member was disqualified, the Ticket Holder shall return the Prize.
- 8.16. FKN Army reserves the right to disqualify any entry that does not comply with these terms or is deemed inappropriate.

9. Announcement of result

- 9.1. The Eligible Ticket Holders will be contacted telephonically and by email to inform them of the outcome of the Initial Draw.
- 9.2. The Winner will be determined on the date of the Competition. With consent of the Winner a video will be taken and posted at the time of actual handover of the Prize.
- 9.3. The name and town of the winner will with consent of the Winner be announced, on the Announcement Date.

11. Receipt of the Prize

- 11.1. The Winner of the Prize shall be entitled to collect the Prize from Sunward Motors Silverton (Pty) Ltd, 466 Pretoria Road, Pretoria, 0184 on prior notice and from Monday to Friday between 09h00 until 16h00 and excluding public holidays.
- 11.2. The FKN Army will provide the required documents to register the Prize into the name of the Winner at the Department of Roads and Transport, Emalahleni and pay for the costs of registration thereof in the name of the Winner (but not the costs of any fines in the name of the Winner).
- 11.3. The Winner will become eligible for the Prize, subject to the Rules, and upon having won the skill-based Competition.
- 11.4. Risk of loss or damage to the Prize will vest in the Winner on collection of the Prize.
- 11.5. The FKN Army reserves the right to require the full proof of identification (identity number), work, email and residential address of the Winner, before release of the Prize.
- 11.6. The Winner shall be required to make arrangements for and collect the Prize within 30 (THIRTY) calendar days of the Live Draw Date.
- 11.7. If the Winner fails to accept and collect the Prize within 30 (thirty) calendar days of the Competition Date, or to make arrangements for same to the reasonable satisfaction of the FKN Army the Prize shall be forfeited and a new Winner shall be determined by means of new skill based Competition between the remainder of the Competitors to be held at the time and manner determined by FKN Army.

11.8. Prizes are non-transferable and may not be exchanged for cash or other alternatives.

12. No warranties are provided

12.1. Other than for the warranties provided by the manufacturer of the Prize (if any), no warranties are provided by the FKN Army in respect to the Prize.

12.2. The FKN Army will provide the Prize, and the Winner will accept all risk of damage, loss, maintenance and repair in respect of the Prize from the delivery date.

13. Indemnity

The Winner, by accepting the Prize, indemnifies (releases from and agrees to protect against) and undertakes to keep indemnified, the FKN Army (as well as its directors, advisors, employees and representatives) in respect of the Prize, its use and operation, and the FKN Army (as well as its directors, advisors, employees and representatives) will not be liable for any accident, injury, damage, harm loss or loss of life that the Winner or any person who uses the Prize may suffer or that any person may suffer resulting from the use of the Prize.

14. General conditions

14.1. The FKN Army shall not be liable for any disruption/delay to the Competition, whether due to technical problems or otherwise. If there is any disruption/delay to the Competition the FKN Army shall use its reasonable endeavours to remedy any disruption/delay and resume or reschedule the Competition in a fair manner and in due course.

14.2. The FKN Army will not be responsible for any failure or inability of a person to buy a Ticket due to interruption, error, delay in operation or transmission, communications failure, website failure, or inability to process an order to buy a Ticket.

- 14.3. A person cannot participate in the Draw unless the whole price of the Ticket or has been paid. Once money has been received for, or on account of, a ticket or chance it cannot be refunded to the participant except if the Draw cannot proceed.
 - 14.4. Ticket sales are open to individuals aged 18 and over.
 - 14.5. The FKN Army reserves the right to amend these rules and the rules of the Competition.
 - 14.6. The laws of the Republic of South Africa will apply to the Competition.
 - 14.7. The Competition is not intended as a lottery but as a skill-based competition between the Competitors.
